2025 UGG Season Prize Draw Official Rules

NO PURCHASE NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: 2025 UGG Season Prize Draw (the "Prize Draw") is open only to legal residents of the United Kingdom ("UK") who are at least eighteen (18) years old at the time of entry and (a) UGG Rewards members or (b) agree to become UGG Rewards members by entering the Prize Draw. Sponsor will hold any personal details it is entitled to hold on its own or a duly authorized agent's database for the purposes of optimizing its commercial offering to consumers, actual or potential. Any individual (or duly authorized person) may elect to exclude the name and email address of that individual from all lists used by Sponsor by submitting a removal request in writing to Sponsor at customerserviceuk@ugg.com or by clicking "unsubscribe" in any communications. By fully completing and submitting the registration form you will receive one (1) entry into the Grand Prize Draw. By registering and entering the Prize Draw, each participant warrants that they have read and agree to abide by these Official Rules and that they meet all eligibility requirements for participating in the Prize Draw.

You may play the Instant Win Game one (1) time per day during the Prize Draw Period and either win an Instant Win Game Prize (Prizes listed in Section 8.A below) or a Grand Prize Draw entry. You may earn a maximum of twenty-nine (29) entries in total into the Grand Prize Draw by this entry method

6. Prize Draw Entry and Game Play Limitations: Only one entrant per email address or UGG Rewards account. Any attempt by any entrant to obtain more than the maximum stated number of entries or game plays (as per Section 4) listed for each entry method by using multiple/different email addresses, identities, UGG Rewards accounts, registrations and logins, or any other methods will void that entrant's entries and game plays and that entrant may be disqualified. Use of any automated system to participate is prohibited and may result in disqualification. In the event of a dispute as to the identity of an entrant, Sponsor and Administrator will rely on the information submitted by the entrant to register for this Prize Draw and/or enroll in UGG Rewards. 7. Instant Win Game Prize Distribution, Prize Drawings and Prize Claim Requirements:

A. Boxes not permitted), and date of birth to confirm eligibility and for purposes of Prize fulfillment within three (3) days of the date notice or attempted notice is sent in order to claim the Grand Prize. Initial package for Grand Prize will be fulfilled approximately 8-10 weeks after conclusion of the Sweepstakes.
- C. - Instant Win Game Prizes (the "Instant Win Game Prize"):

Ten (10) Shoe Prizes: Winner will receive Shoe Prize as one (1) digital code worth up to £150 via email within seven (7) business days. Digital code will only be applicable towards the purchase of one (1) footwear style and can be used online only at ugg.com. Digital code is one time use and any remaining value will be forfeited. If the footwear style selected is over £150, the winner is responsible for providing a payment method for the balance. When digital code is used online at ugg.com free standard shipping will be included. Digital code will expire on December 31, 2025 11:59 p.m. GMT. Any digital codes not used by this time will be invalidated and will not be reissued by Sponsor. ARV: £150.

Twenty (20) Apparel Prizes: Winner will receive Apparel Prize as one (1) digital code worth up to £110 via email within seven (7) business days. Digital code will only be applicable towards the purchase of one (1) apparel style and can be used online only at ugg.com. Digital code is one time use and any remaining value will be forfeited. If the apparel style selected is over £110, the winner is responsible for providing a payment method for the balance. When digital code is used online at ugg.com free standard shipping will be included. Digital code will expire on December 31, 2025 11:59 pm GMT. Any digital codes not used by this time will be invalidated and will not be reissued by Sponsor. ARV: £110.

Thirty (30) Accessory Prizes: Winner will receive Accessory Prize as one (1) digital code worth up to £75 via email within seven (7) business days. Digital code will only be applicable towards the purchase of one (1) accessory style and can be used online only at ugg.com. Digital code is one time use and any remaining value will be forfeited. If the accessory style selected is over £75, the winner is responsible for providing a payment method for the balance. When digital code is used

online at ugg.com free standard shipping will be included. Digital code will expire on December 31, 2025 11:59 pm GMT. Any digital codes not used by this time will be invalidated and will not be reissued by Sponsor. ARV: £75.

Fifty (50) UGG Care & Cleaning Prizes: Winner will receive the UGG Care & Cleaning Prize as one (1) digital code worth up to £55 via email within seven (7) business days. Digital code will only be applicable towards the purchase of one (1) UGG Care & Cleaning product or kit and can be used online only at ugg.com. Digital code is one time use and any remaining value will be forfeited. If the UGG Care & Cleaning product or kit selected is over £55, the winner is responsible for providing a payment method for the balance. When digital code is used online at ugg.com free standard shipping will be included. Digital code will expire on December 31, 2025 11:59 pm GMT. Any digital codes not used by this time will be invalidated and will not be reissued by Sponsor. ARV: £55.

One Hundred (100) Sock Prizes: Winner will receive Sock Prize as one (1) digital code worth up to £15 via email within seven (7) business days. Digital code will only be applicable towards the purchase of one (1) sock style and can be used online only at ugg.com. Digital code is one time use and any remaining value will be forfeited. If the sock style selected is over £15, the winner is responsible for providing a payment method for the balance. When digital code is used online at ugg.com free standard shipping will be included. Digital code will expire on December 31, 2025 11:59 pm GMT. Any digital codes not used by this time will be invalidated and will not be reissued by Sponsor. ARV: £15.

B. Terms and Conditions of Instant Win Game Prize digital codes:

All Instant Win Game Prize digital codes are one time use and any remaining value unused will be forfeited. Winner is responsible for providing a payment method for any balance above the digital code. If digital code is used online at ugg.com free standard shipping will be included. Any returns will not result in a digital code being reissued. Only exchanges will be honored through the standard UGG exchange policy. Digital code will expire on December 31, 2025 11:59 pm GMT. Any digital codes not used by this time will be invalidated and will not be reissued by Sponsor.

- **C.** Odds of Winning: The odds of winning a Grand Prize depend on the total number of eligible entries received from UK residents during the Prize Draw Period. Odds of winning an Instant Win Game Prize depend on the date/time of entry, the number of Prizes remaining available at the time of entry and the number of eligible Instant Win Game plays received.
- D. Additional Terms For All Prizes: Prizes are non-transferable, non-exchangeable, and have a cash value of zero. No substitution of the Prizes will be made except as provided herein at the Sponsor's reasonable discretion. Sponsor reserves the right to substitute a Prize for one of equal or greater value if the designated Prize should become unavailable for any reason. Where applicable, Prize style, size, and all other details will be determined by Sponsor in its reasonable discretion. All other costs and expenses associated with acceptance of the Prize that are not expressly set forth herein shall be solely the winner's responsibility. The Prizes may be forfeited in the event that Sponsor determines the Prizes are being misused. Limit of one (1) Instant Win Game Prize and one (1) Grand Prize per person.
- **9. Release:** To the extent permitted by applicable law, each participant agrees to release, discharge, indemnify, defend and hold harmless Sponsor, Administrator and their respective parent, subsidiaries, affiliates, shareholders, employees, officers, directors, agents, representatives, advertising and promotion agencies and prize suppliers from any liability arising from or related to the Prize Draw, including without limitation, personal injury, death, and property damage, and claims based on publicity rights, defamation, or invasion of privacy. Where permitted by law, Sponsor, Administrator and their respective subsidiaries, affiliates, retailers, and agents, and each of their officers, directors, employees and agents ("Sponsor Affiliates") will not be responsible or liable to compensate a winner or accept any liability for (i) any losses

that were not caused by any breach of these Official Rules by Sponsor, Administrator and/or Sponsor Affiliates (ii) any business loss (including loss of profits, revenue, contracts, anticipated savings, data, loss of goodwill, or wasted expenditure), or (iii) any indirect or consequential losses that were not foreseeable to both at the time winner began participating in the Prize Draw or using, if applicable, any Prize. Sponsor, Administrator and the Sponsor Affiliates will also not be responsible for any delay or failure to comply with its obligations under these Official Rules if the delay or failure is attributable to circumstances beyond Sponsor's, Administrator's and/or Sponsor Affiliates' reasonable control. This provision does not affect a Prize winner's right to receive the relevant Prize within a reasonable time. Nothing in these Official Rules limits or excludes Sponsor's, Administrator's and/or Sponsor Affiliates' responsibility to UK entrants for fraudulent representations or for death or personal injury caused by negligence or willful misconduct.

- 10. Publicity: Except where prohibited by applicable law, participation in the Prize Draw constitutes each winner's consent to have their first name, last initial, locality/Post Town, as applicable, publicly disclosed (see Section 16) after winner confirmation is complete. Winners acknowledge that the Sponsor may disclose relevant information about winners to the UK's Advertising Standards Authority, if necessary but retain the right to object to this information being published or to request a reduction in the amount of information published. Sponsor may also request the winner's consent to the Sponsor's use of the winner's name, Prize information, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, without further payment or consideration. The winner is under no obligation to grant this consent. Upon receipt of such consent, Sponsor is not obligated to use any of the above-mentioned information or publicity materials but may do so and edit such information or materials at its reasonable discretion, without further obligation or compensation.
- 11. General Conditions: Sponsor reserves the right to cancel, suspend and/or modify the Prize Draw, if any fraud, technical failures, human error, or any other factor impairs the integrity or proper functioning of the Prize Draw, or any event or cause beyond Sponsor's control (e.g. events such as natural calamities, national emergencies, wide spread illnesses, declarations of war, acts of God, acts of terrorism) interferes with any aspect of the Prize Draw, including but not limited to fulfillment of the Prize(s), as determined by Sponsor in its reasonable discretion. In such event, Sponsor, in its reasonable discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance and may modify the Prizes offered herein. Sponsor reserves the right, in its reasonable discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Prize Draw, including but not limited to submitting fraudulent entries, or to be acting in violation of the Official Rules of this or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Prize Draw may be a violation of criminal and civil law, and should such an attempt be made. Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In no event will more Prizes than are stated in these Official Rules be awarded. If, for any reason, more Prize notifications are sent (or more claims are received) than the number of Prizes offered as set forth in these Official Rules, Sponsor reserves the right to award the intended number of Prizes through a random drawing from among all eligible Prize claims received. In the event there is a discrepancy or inconsistency between any other statements contained in any Prize Draw-related materials (including printed versions of these Official Rules) and the Official Rules as posted on the Prize Draw Site, the Official Rules as posted on the Prize Draw Site shall prevail, govern, and control.
- **12. Limitations of Liability:** Except as prohibited by law, Sponsor and the Released Parties are not responsible for: (a) any incorrect or inaccurate information either caused by printing errors or by any of the equipment or programming associated with or utilized in the Prize Draw or provided by entrants; (b) technical failures of any kind, including but not limited to malfunctions, interruptions or disconnections to the internet, in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the Prize Draw, including but not limited to the entry process; (d) technical or human error which may occur in the administration of the Prize Draw, including but not limited to the processing of entries; (e) late, lost, undeliverable, damaged or stolen mail; or (f) to the extent permitted by applicable law, any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from

entrant's participation in the Prize Draw, or to the receipt, use, inability to use, or misuse of any Prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Prize Draw, if it is possible.

- **13. Disputes:** All disputes will be resolved as set forth in the UK UGG Rewards <u>Terms and Conditions</u>, which require, among other things, the application of the law of England or Wales, that any cause of action relating to the UGG Rewards program will be brought to competent courts in England and Wales or by mediation/alternate dispute resolution and the waiver of both the right to a jury trial and a class action lawsuit.
- **14. Severability:** If the application of any provision of these Official Rules to any particular facts or circumstances shall for any reason be held to be invalid, illegal or unenforceable by a court, arbitration panel or other tribunal of competent jurisdiction, then (a) the validity, legality and enforceability of such provision as applied to any other particular facts or circumstances, and the other provisions of these Official Rules, shall not in any way be affected or impaired thereby; and (b) such provision shall be enforced to the maximum extent possible. In addition, if any provision contained in these Official Rules shall for any reason be held to be excessively broad as to duration, geographical scope, activity or subject, it shall be construed by limiting and reducing it, so as to be enforceable to the extent compatible with applicable law.
- 15. Entrant's Personal Information: When you enter this Prize Draw, you provide certain personal data to the Sponsor, including your valid email address. For this purpose, the Sponsor is a data controller of any personal data that you provide. Where the provision of any personal data is marked as a mandatory field for the purposes of the Prize Draw, should you refuse to provide such data, your entry into the Prize Draw will not be valid. Personal data will be used to administer the Prize Draw, contact potential winners and allocate the Prizes, and to enroll entrants as UGG Rewards members (if not a member already) and share relevant UGG Rewards communications with such entrants. The U.S. government maintains access rights and personal data may be subject to subsequent processing without comprehensive legal restraints (i.e., the Sponsor and/or the Administrator may be required, under U.S. law, to share your personal data with U.S. governmental authorities, courts, or other regulators).
