UGG Season Sweepstakes Official Rules

- 1. Eligibility: UGG Season Sweepstakes (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are at least eighteen (18) years old at the time of entry and who are UGG Rewards members. Employees of Deckers Outdoor Corporation, Merkle Inc., and their parent and affiliate companies, suppliers as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Promotion is subject to all applicable federal, state, and local laws and regulations and is void where prohibited. How to Enter: During the Promotion Period, visit https://www.ugg.com/uggseasonsweepstakes/ and complete and submit the registration form including a valid email address associated with your UGG Rewards membership. Membership in UGG Rewards is free. If you are not an UGG Rewards Member, you will become a member by completing the registration form with the information indicated on the form and accepting the UGG Rewards Terms and Conditions (https://www.ugg.com/loyalty-terms-and-conditions.html) and Privacy Policy (https://www.ugg.com/privacy-policy.html). You automatically will receive one (1) entry into the Sweepstakes and advance to the Game page and receive one (1) Game play for that day. The Game results will be instantly displayed. Potential winners of the Game will be provided directions for validation. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Game.
